

Confidentiality Assi Notice: 1) By submitting this application the applicant acknowledges that if a subsidy is granted, all amounts payable will be submitted punctually. It is understood that subsidies are conditional upon your account remaining current. Our devoted administration cannot afford to take time allocated to raise funds to cover subsidies to pursue the portion of the fees that each successful applicant is responsible for. As a result, unnegotiated failure to meet the payment schedule that will be sent to each successful applicant will result in immediate cancellation of the subsidy and the applicant will become responsible, retroactively, to pay full tuition.
